Assignment Validation Software (AVS) Suite
Academic Software License**

This is an academic license for the program packages AutoAssign copyright, 1998, 1999, 2002 by D.E. Zimmerman, H.N.B. Moseley, C. Kulikowski and G.T. Montelione and Rutgers, the State University of New Jersey for automated analysis of protein resonance assignments from NMR data; AutoPeak, copyright 2001, 2002, 2003 by Hunter Moseley, Gaetano T. Montelione and Rutgers, the State University of New Jersey, for manipulation of peak list files and NMRStar formatted files; and Assignment Validation Software (AVS) copyright 2003 by Hunter Moseley, Gaetano T. Montelione and Rutgers, the State University of New Jersey, for evaluation of protein NMR resonance assignments. These program packages, AutoAssign, AutoPeak, and AVS, which together are referred to as the Software. The AutoAssign program package includes executable computer code for the AutoAssign C++ server and the AutoAssign Java client, documentation, and example data files. The AutoPeak program package includes executable computer code for a suite of programs written in C++ and Perl scripts, as well as documentation for their use. The AVS program package includes a suite of programs written in Perl and Java as well as documentation for their use.
